COMMENTS:

XTO Energy Inc. is operating a gas gathering system with a central compressor station, satellite compressor stations and wellhead compressors to pull approximately 7 psi of vacuum at the wells. Attached is a map showing the location of the above referenced well that XTO would like to put on a vacuum. Oxygen monitors are located at each satellite compressor station. If oxygen levels exceed 10 ppm at the main XTO gas sales meter, gas sales will be shut off until the levels are returned to 10 ppm or less. Oxygen monitors throughout the system will be used to locate the source of the oxygen problem. Actions will be taken to correct the problem.

There are no operators other than XTO Energy within 1/2 mile radius.
