COGCC discussed with operator whether this equipment change could be accomplished with a Form 4 Sundry or a Form 2A to amend the Location; per operator, all work would be conducted within originally disturbed area, and delays in processing may result in shut in of wells; equipment placed on this pad will support offsite injection operations.
