## COMMENTS:

The purpose of this COGCC Form 4 is to permit transportation of drill cuttings and cut slope material from the RWF 23-32 well pad (COGCC facility #334748) to the RWF 342-33 well pad (COGCC facility # 311599) and the Quarter Circle 43-33H well pad (COGCC facility # 334690). The subject drill cuttings were generated in 2008 during drilling activities at the RWF 23-32 well pad. The cuttings were managed and disposed of in a permitted reserve pit which was sampled and closed in 2008 in accordance with the COGCC Rules applicable at that time.

26,000 cubic yards of material will be removed from the cut slope and 9,000 cubic yards of pit material will be excavated from the pit area and transported to the RWF 342-33 and Quarter Circle 43-33H well pads where the material will be managed on the pad surface and the land adjacent to the well pads; the pads' surface and adjacent land is owned by WPX Energy (see attached map for pad locations).

The pit material will be managed separately from the cut slope material. Once the pit material is transported to the new locations, one composite baseline sample will be collected from every 1,500 cubic yards of the pit material and analyzed for the constituents listed in the COGCC Table 910-1. If the material tests above the cleanup standards for organic compounds, it will be treated on location with a bioremediation product or it will be diluted with the cut slope material. After every treatment, confirmation samples will be collected and analyzed for constituents that exceeded the COGCC requirements.

If the pit material tests above the cleanup standards for the inorganic compounds, the material will be covered with a minimum of 3' cap during the reclamation activities, to ensure successful re-vegetation of both sites.

A Form 4, notice of completion report, will be submitted to COGCC upon completion of the activities described above.
