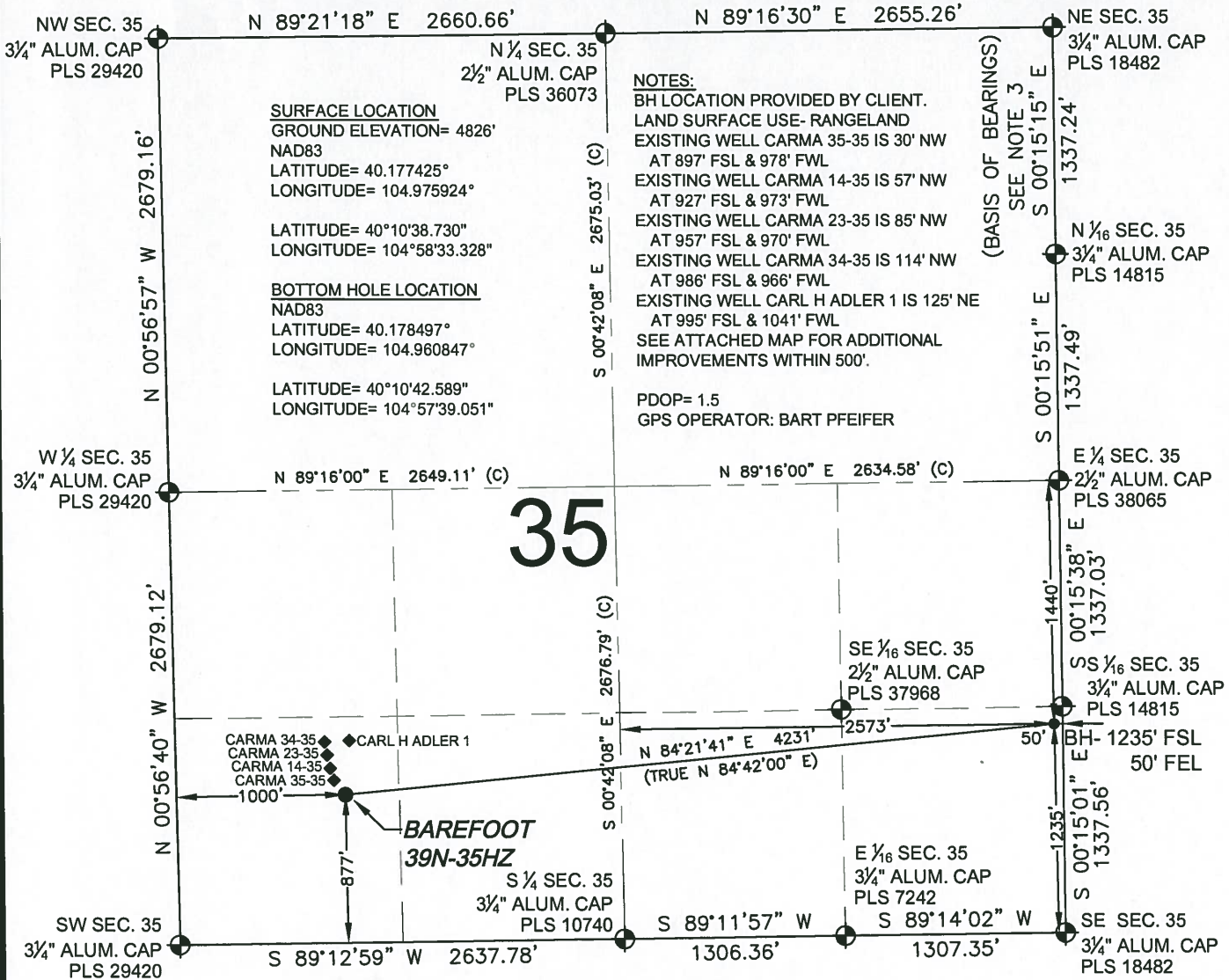


# WELL LOCATION CERTIFICATE: BAREFOOT 39N-35HZ

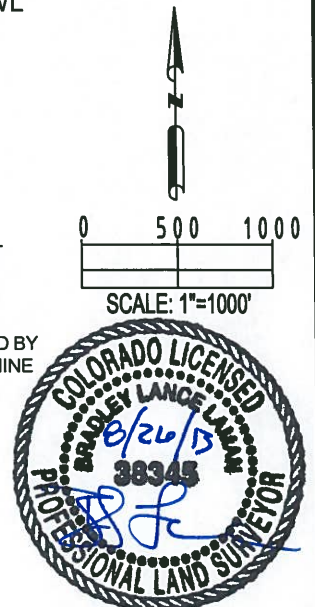
