Comments Operator certifies all conditions remain the same from original permit and subsequent sundries, except for change to name, formation, and casing info. Permit is being refilled in order to have enough time to mitigate any possible offset wellbore integrity issues before drilling and completion. 7" casing string will be cemented to at least 200' above Niobrara, around 500' from surface. CBL will only be run in the vertical section of the wellbore. Distance to nearest well measured to State Corsair 23-26.
