Encana Oil & Gas (USA) Inc. requests permission to perform a cement remediation job on the subject well in order to adhere to the DJ Offeset Policy for the APC Underhill Horizontal Pad.

The planned procedure is as follows:

1. Hold a pre-job safety meeting. Discuss all aspects of the procedure with any involved personnel. Identify and address any safety concerns before the job begins.
2. MIRU pulling unit. Kill well with produced water.
3. ND wellhead, NU BOP.
4. POOH with tubing. Replace joints as needed.
5. Un-land 4-1/2" production casing.
6. RIH down 4-1/2" by 8-5/8" annulus with 1-1/4" tubing to 900'.
7. Establish circulation and pump 180 sxs of class G neat cement, taking returns up annulus to surface.
8. POOH and lay down 1-1/4" tubing.
9. Re-land 4-1/2" casing
10. Run CBL and log from 1000' to surface'
11. RD E-line.
12. RIH and Hydrotest completion as follows: Seat nipple/EOT @ 8127' 2-3/8 tubing to surface
13. RIH with tubing broach to verify drift.
14. ND BOP, NU wellhead.
15. RDMO Workover rig.
