Operator Comments:

Oxy has completed the investigation and follow-up sampling of a spill that occurred on the Hawkins 10-9 pad (Reference REM #4453), and requests to apply a different standard to the COGCC Table 910-1 concentration level for Arsenic (As), based on post remediation samples being statistically equal or within 10% of undisturbed background levels. Oxy's sundry requests to waive the COGCC Table 910-1 concentration for As. In this particular situation, the post remediation samples (11/12/2013) As concentrations are above COGCC table 910-1 standards, but are within 10% of undisturbed background levels (see sampling locations on included location maps).

The sampling method Oxy employed was to take a representative random grab sample for each background sample location. The analytical concentration tables identify the COGCC Table 910-1 concentration levels, Oxy's undisturbed background concentrations, and the post remediation concentrations. Based on the background sample concentrations, Oxy's sundry notice requests to apply a different standard to the COGCC Table 910-1 concentration level in regards to As.
