- 7) Trip in 1 1/4" tubing down annular w/ mule shoe to 4760'; condition hole
- 8) RU cement crew, POOH to 4710', pump 227 sxs 13.5ppg 50/50poz cement bringing cement to 3515', ~250' above top of Parkman
- 9) POOH above 3515', roll hole clean. POOH to 675', condition hole
- 10) RU cement crew, POOH to 625', pump 148 sxs 15.8 ppg G neat cement, POOH to within 50' of surface casing shoe @ 309'
- 11) Roll hole clean, leaving BrHd "open." POOH with 1 1/4" tubing, land casing.
- 12) SI well overnight, run CBL recording new cement depths
- 13) Clean out hole, retrieve RBP
