An MIT was performed on 11/7/2013; while working on the well to return it to production the packer became stuck. All attempts to release it were unsuccessful. The standing valve placed above the packer also became stuck and attempts to retrieve it were unsuccessful. End of tubing is at 6746', top of fish is at 6780' and the packer is at 6840'. Well is temporarily abandoned.
