OXY USA WTP LP (Oxy) is providing this 12-month status update as part of the conditions of approval for the 18-month Cascade Creek 697-15-01 Cuttings Disposal Area (697-15-01 CDA) interim reclamation request, reference approved document # 02369026. Oxy plans to utilize the 697-15-01 CDA to support drilling and completions activities for one well located on the 697-09-61 pad to be drilled in March 2014, and twelve wells located on the 697-15-54 well pad to be drilled in May of 2014. Continued monitoring of revegetation will be conducted at the site as part of Oxy's stormwater program. Oxy will notify the COGCC once the site is reopened for additional cuttings storage and disposal.
