COMMENTS:

WPX Energy requests approval to construct an 10'x20' x8' depth cement return trench located within the cuttings management area. The reason for this request is that the cement program volumes have changed and we expect excess cement, spacer, and drilling mud to surface. Approximately 200 BBLs total volume is expected. Free liquids will be removed via vac truck as soon as practical and only de minimis fluids will be stored. The cement return trench will be sampled and closed in accordance to COGCC 900 and 1000 series rules. The location of this trench is shown on the attached drawing.
