The failed valve allowed approximately 67 bbls of condensate to release to the South Platte River. A hydrocarbon sheen was observed around the oil tank. The sheen migrated north, and was observed in the ditches along 49th street in Evans, CO.</u>		

**CORRECTIVE ACTION**

Describe immediate response (how stopped, contained and recovered): Deflective and absorbent booms were deployed to contain the residual release and minimize downstream impacts. A vacuum truck was used to recover impacted floodwater along the ditches of 49th street in Evans, CO.

How was the extent of contamination determined? A sampling and analysis plan will be developed once the floodwaters recede.



