**Operator Comments:**

Oxy has completed placing and staging the mixed cuttings on the Shell 797-03B pad as part of the Shell 797-03A and Shell 797-03B Cuttings Management Area plan. Oxy is requesting to apply a different standard to the COGCC Table 910-1 concentration levels for Arsenic (As), based on staged mixed cuttings, and cap sample As levels being below undisturbed background levels. Oxy's sundry request to waive the COGCC Table 910-1 concentration for As. In this particular situation, the staged mixed cuttings samples (08/05/2013) and cap samples (05/06/2013) As concentrations are above COGCC table 910-1 standards, but are below undisturbed background levels (see sampling locations on included location maps).

The sampling method Oxy employed was to take a representative random grab sample for each background sample location. The analytical concentration tables identify the COGCC Table 910-1 concentration levels, Oxy's undisturbed background concentrations, Oxy's mixed and staged cuttings concentrations, and Oxy's cap concentrations. Based on the background sample concentrations, Oxy's sundry notice requests to apply different standards to the COGCC Table 910-1 concentration levels in regards to As.

To address elevated concentrations of pH and SAR, Oxy capped the staged mixed cuttings with at least three feet of native material to ensure a sufficient agronomic zone. The reclaimed cuttings area was contoured along the cut slope to minimize stormwater runoff and to allow for infiltration. Final pad reclamation will occur at the end of the life of pad which will continue to be utilized as a natural gas pad until that time.
