Gunnison Energy is requesting closure of a produced water spill reported via Form 19 on February 14, 2013 (spill tracking #2232039). Impacted soils were excavated and disposed to Adobe Buttes Landfill on May 24, 2013. Samples collected from the excavation indicated concentrations meet constituents outlined in COGCC Table 910-1.
