Re-entry is necessary to adequately re-plug the subject well due to the nearby proximity of a Horizontal well. GPS data will be taken upon conclusion of plugging operations and noted on the Form 6. No pit will be required. A new form 2A is not required as the disturbance will not be increased. The current and proposed well bore diagrams are attached. The procedure for plugging this well is attached.

*NOTE Per original completion report Schlumberger found base of surface casing at 51' and that 20' of the surface casing had fallen off and was at 100'.

*Note- The completion report did not have a weight listed.
