There are no water wells located in Section 34. The nearest water with depth information is in Section 33, 4008' away with an elevation of approximately 5107'. DTW is listed in this well as 8' (receipt #9090557). There is another water well in Section 33 in SW 1/4 6808' feet away and a water well in Section 26, 4516' away. Neither of these wells provide any data. There is a minute amount of surface water in the entire section of 34. Existing oil well were reviewed in section 34, but no DTW could be determined. I don't believe 8' is a true representation of the DTW at our proposed location due to distance and elevation. 26' DTW is a best estimated evaluation.
