Sorry for the delayed response. The Form 27 for the Ritchie State 1-12 has been assigned REM #8108/DOC #2147179. The Form 4 was assigned DOC #2147180. Please note that Form 4 Sundries can now be completed in eForms, which allows easier data entry and faster processing.

Conditions of Approval:

Per Rule 1004.c, the access road shall be closed, graded and recontoured. A variance under Rule 502.b may be requested to preserve the access road or for other landowner requests that are not in accordance with COGCC rules.

Upon completion of reclamation operator shall remove all materials used for storm water control and fencing and properly recycle or dispose. Submit a Sundry Notice Form 4 requesting a Final Reclamation Inspection when final reclamation threshold has been satisfied in accordance with COGCC Rule 1004. The remediation project will remain open until COGCC performs and passes final reclamation inspection. Notify surface owner of planned reclamation and coordinate activities to account for current surface use.
