Attached is an exhibit that shows the GV 86-2 pad. We have found that the south west corner has a buried power line (purple line) that is further into the pad than we first thought. If we cannot cut this corner then we do not have enough material to get the pad we need.  
Our solution is to cut out material that is behind the currently installed production equipment to make up the fill material that we need. This area is indicated in red. (see attached)
