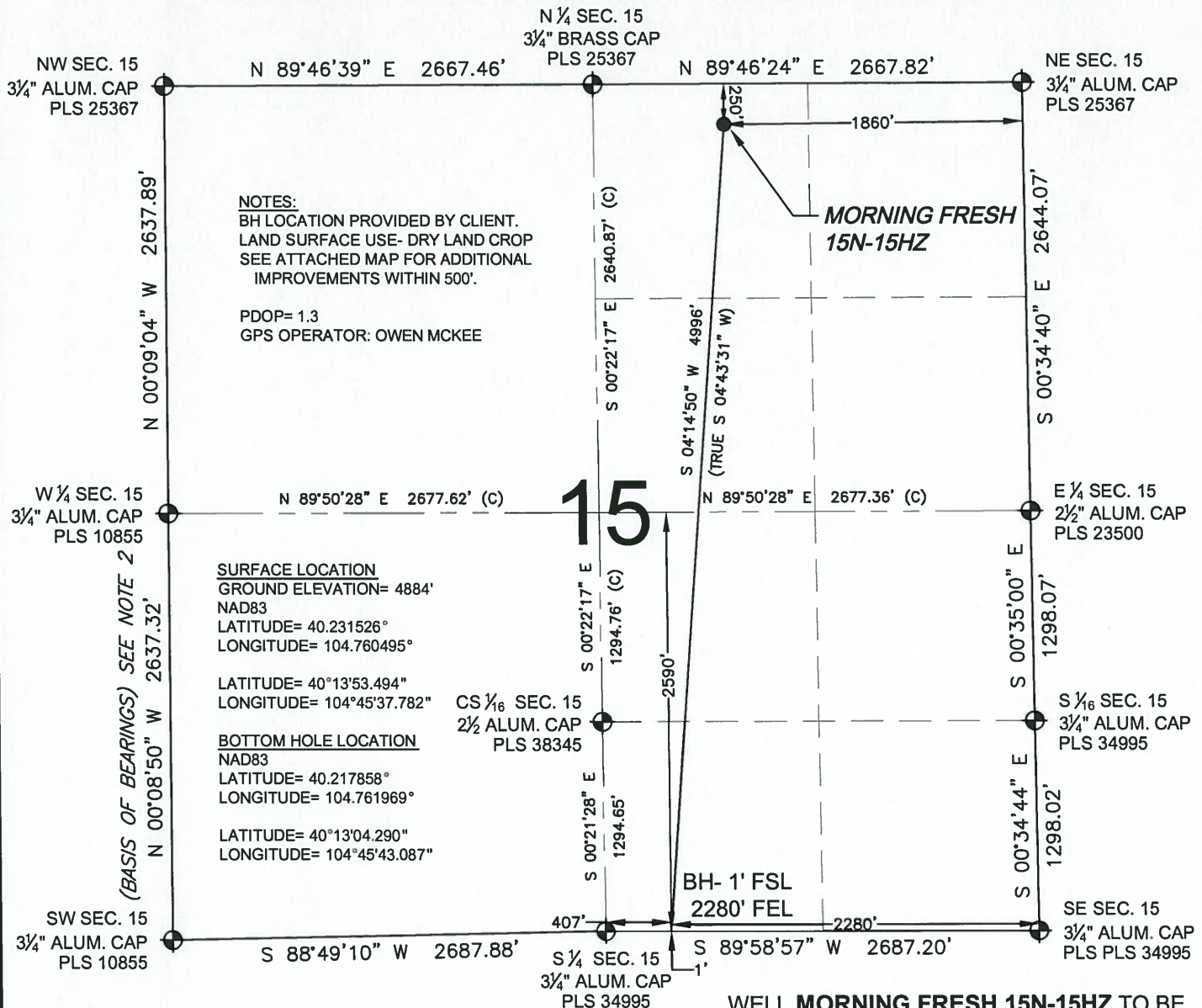


WELL LOCATION CERTIFICATE: MORNING FRESH 15N-15HZ

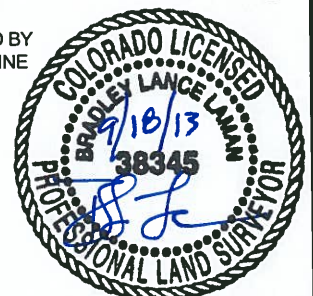
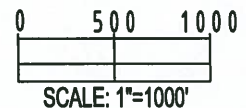
