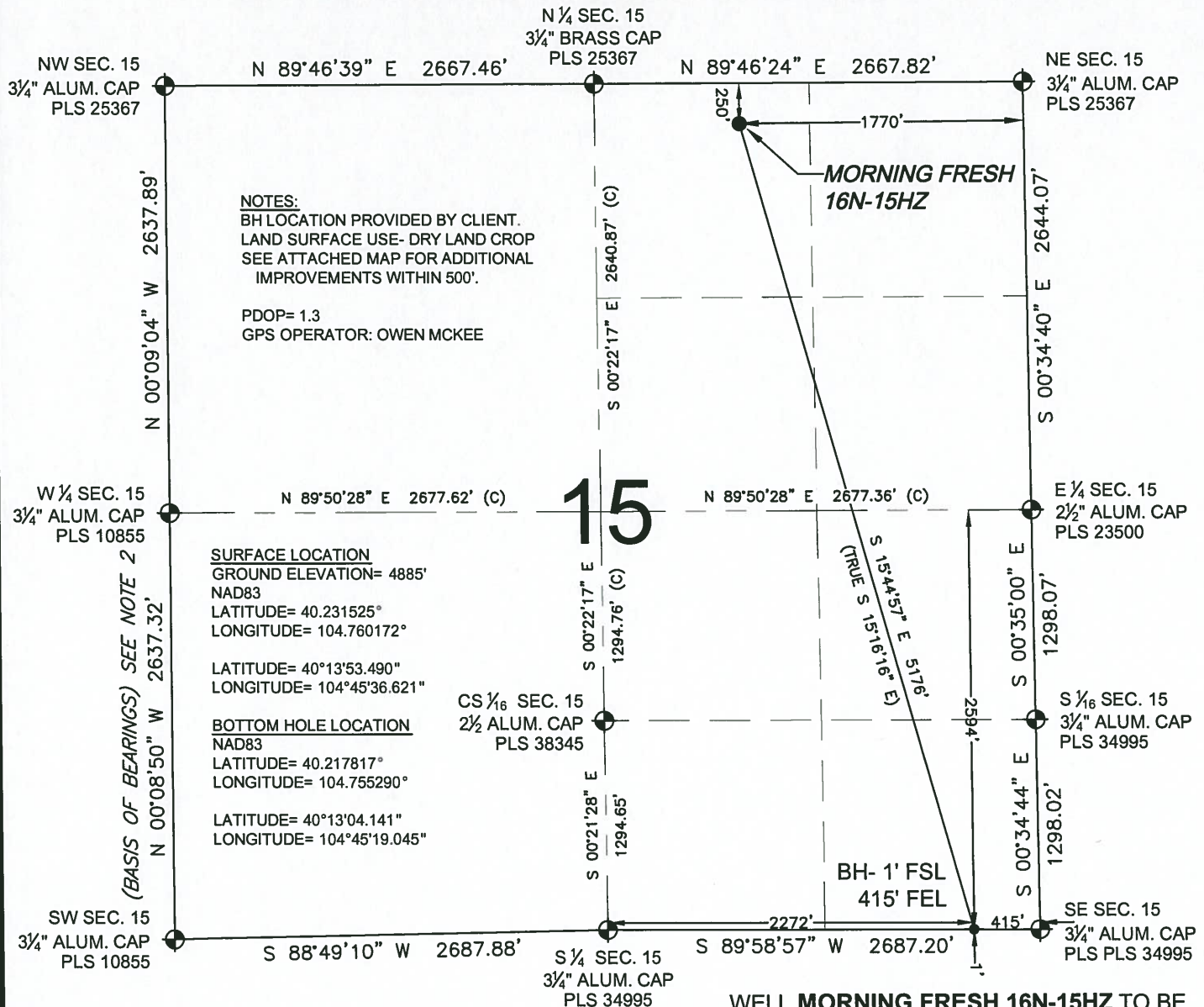


WELL LOCATION CERTIFICATE: MORNING FRESH 16N-15HZ

LOCATED 250' FNL AND 1770' FEL

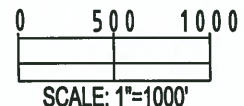
