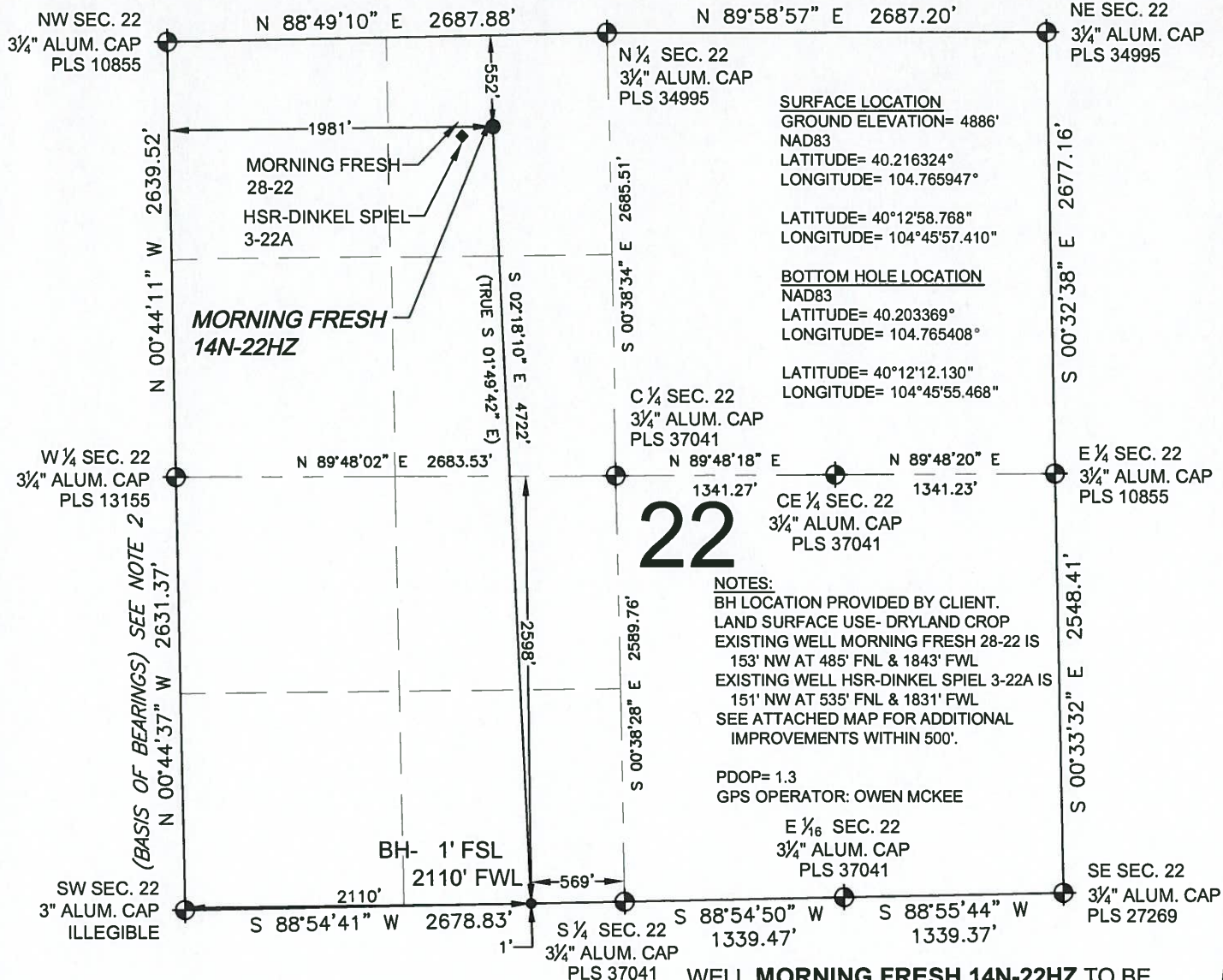


WELL LOCATION CERTIFICATE: MORNING FRESH 14N-22HZ

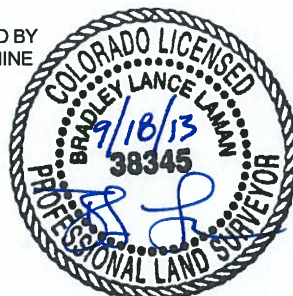
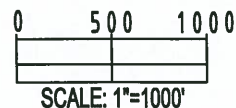
