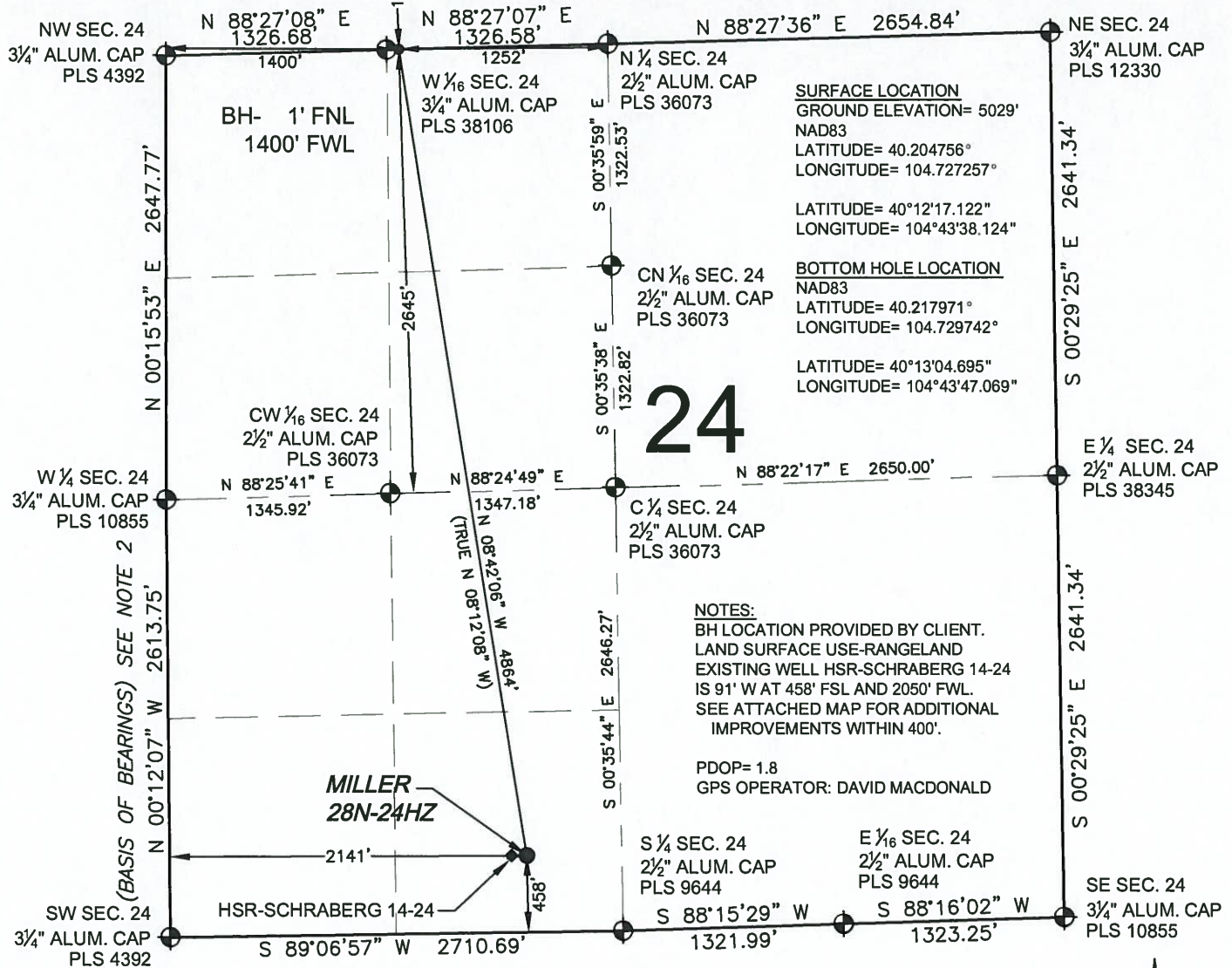


# WELL LOCATION CERTIFICATE: MILLER 28N-24HZ
