Comments:

Interim reclamation activities were conducted on the Hart Gulch 1-17 location during autumn 2013. Interim reclamation activities consisted of conducting excavation work for stormwater BMP management maintenance, reworking stormwater containment structures, and conducting some surface roughening techniques on cut and fill slopes to enhance moisture capture and minimize erosion potential, in preparation of hydroseeding.

On October 31, 2013, hydroseeding and hydromulching with Flexterra was conducted on the cut and fill slopes on the Hart Gulch well pad location and along the access road leading to the well pad. Hydroseeding application used a seed mix approved by the Routt County Conservation District for non-crop lands, RCCD #1 seed mix. RCCD #1 was applied on approximately 1 acre and an application rate of 48.4 PLS lb/acre for a total seed application rate of 48.4 PLS lb.

Ongoing monitoring will be conducted in 2014 to determine the effectiveness of the autumn 2013 interim reclamation measures.
