- 3) Comply with Rule 321. Run and submit Directional Survey from TD to base of surface casing. Ensure that the wellbore complies with setback requirements in commission orders or rules prior to producing the well. The Completed Interval Report, Form 5A will explicitly detail how those portions of the well outside of the legal setback are isolated from production.
