**Operator Comments:**

Oxy has completed reclamation of the above-mentioned reserve pit and requests to apply a different standard (see table on next page) to the COGCC Table 910-1 concentration levels for Arsenic (As), based on post reclamation and mixed pit contents sample As levels being below undisturbed background levels. Based on the background sample concentrations, Oxy's sundry notice requests to apply different standards to the COGCC Table 910-1 concentration levels in regards to As.

In this particular situation, the post reclamation samples (11/01/2013), and mixed pit contents (11/01/2013 and 10/28/2013) As concentrations are above COGCC table 910-1 standards, but are below undisturbed background levels (see sampling locations on included location maps).

The sampling method Oxy employed was to take a representative random grab sample for each background sample location. The analytical concentration tables identify the COGCC Table 910-1 concentration levels, Oxy's undisturbed background concentrations, Oxy's post reclamation concentrations, and Oxy's mixed pit contents concentrations.

Oxy backfilled the pit with the mixed pit contents and graded it to be level with the working surface of the pad to minimize stormwater runoff. Oxy intends on the continued use of the backfilled pit as part of the working surface of the pad and therefor requests to postpone the placement of a cap until the end of the life of the pad. To address elevated concentrations of pH, Oxy will cap the mixed pit contents at the end of the life of the pad during final pad reclamation. The cap will consist of at least three feet of native material to ensure a sufficient agronomic zone. Final pad reclamation will occur at the end of the life of pad.
