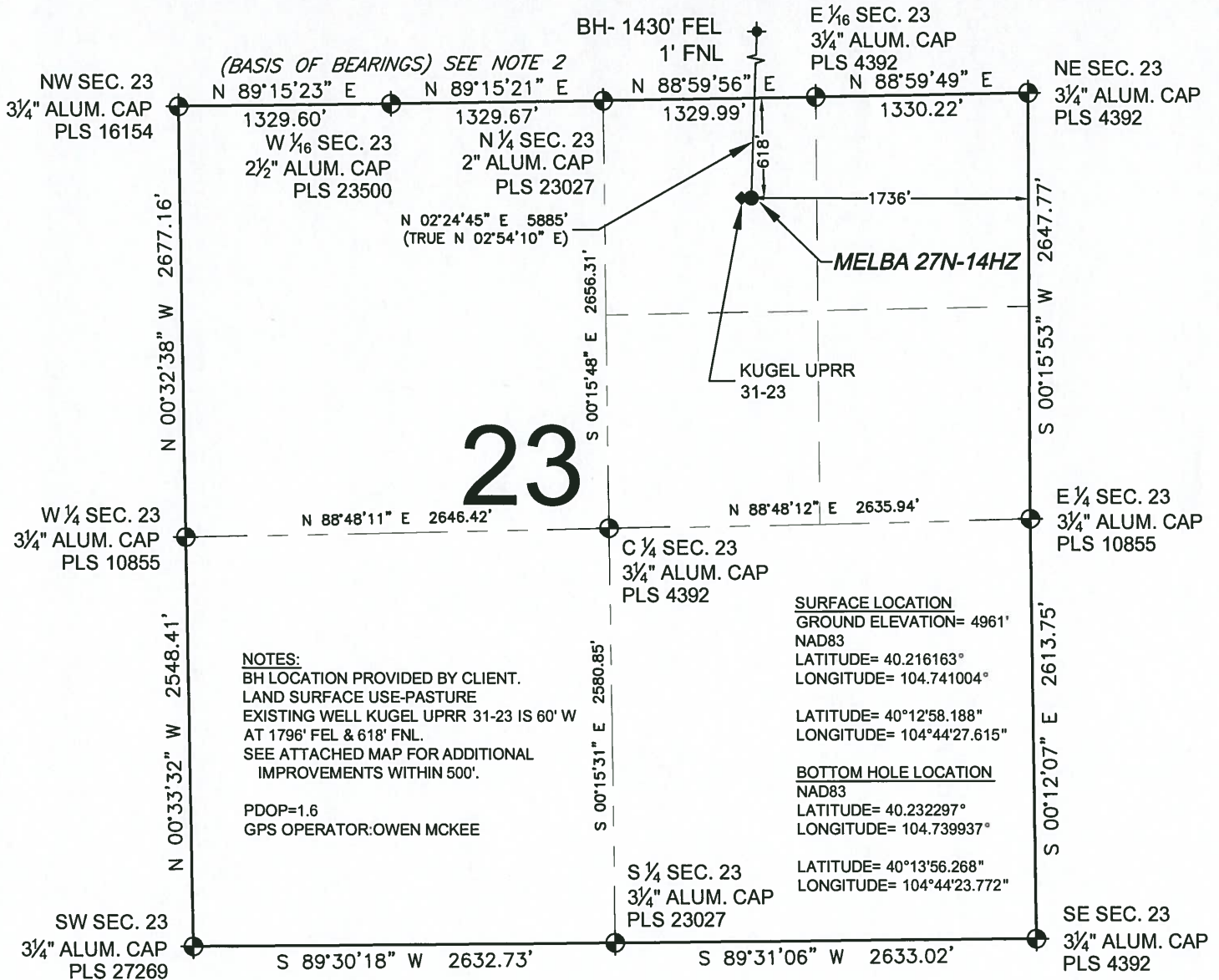

WELL MELBA 27N-14HZ TO BE LOCATED 1736' FEL AND 618' FNL

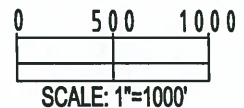

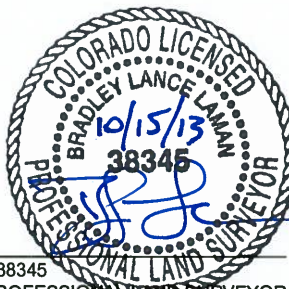

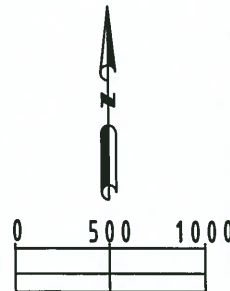
