

Dear Mr. Kohler,

In accordance with the requirements of Rule 305.f. of the Colorado Oil and Gas Conservation Commission (COGCC), this letter serves as Statutory Notice by Ward Petroleum Corporation (WPC) of its intention to conduct drilling operations on the captioned well located on your property. WPC, as operator, estimates operations to begin within 180 days, pending receipt of required permits, approval of title and drilling rig availability.

The proposed location of the subject well is as follows, with a Location Drawing attached for your reference:


WPC Federal 14-5: 2383' FSL, 2047' FWL, Section 14, Township 10 North, Range 64 West

As the surface owner, it is your responsibility to give notice of the proposed operations to any tenant farmer, lessee or other party that may own or have an interest in any crops or surface improvements that could be affected by the proposed operations.

Pursuant to COGCC Rule 306.a, the affected surface owner is entitled to a consultation with the operator. Enclosed are a Consultation Form and a self-addressed stamped envelope for your use in returning the Consultation Form with your election. Also enclosed are copies of the COGCC Informational Brochure for Surface Owners and the COGCC Policy for Onsite Inspections.
