Arthur, as per our phone conversation this morning please find attached an aerial map depicting the field verified locations of the well in question in regards to the Tebo 29-2H Sundry Notice.

I believe the specific well in question for this location was permit #111807. The location was field verified on 11/21/2013 and is located outside the ½ mile radius from the Tebo 29-2H location.

Also, as I mentioned on the phone I spoke in person with a Mr. Neil Hummel regarding his well #119101-A and he indicated that his well was incorrectly spotted on the COGCC map and also that another well spotted on the map (#92414-VE) did not exist. Well #258652 owned by Duane and Nicole Bartley was previously sampled to satisfy ConocoPhillips' MOU requirements with Arapahoe County.

Please let us know if you need any additional information to approve the Sundry Notice for the Tebo 29-2H location.

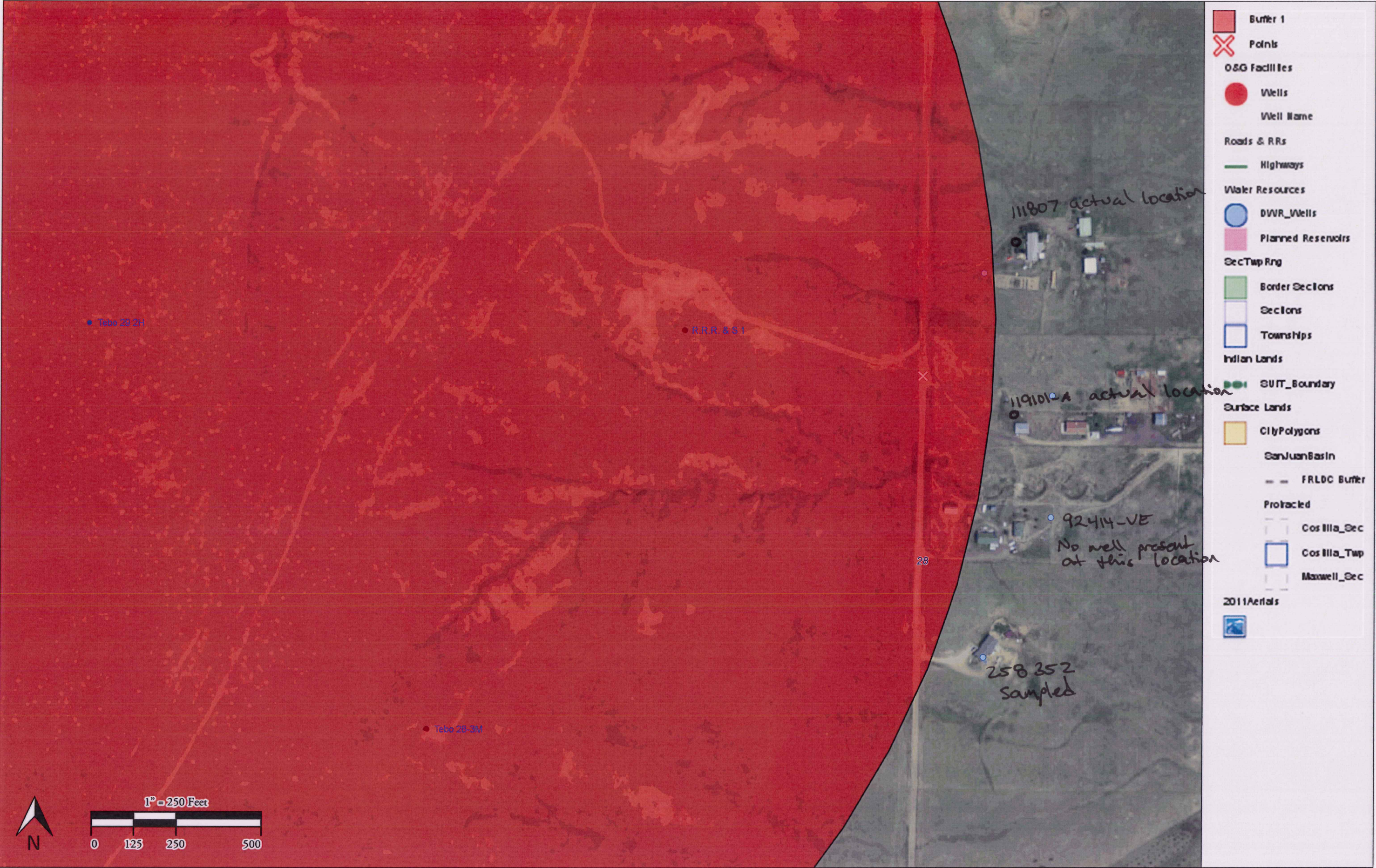

I went out today and verified the location of the well in question (permit #111807) for the Tebo 29-2H location as the DWR well documents appeared to have some errors. Please see the attached map indicating the field verified locations of the well in question which places it outside the ½ mile radius of the Tebo 29-2H location.

Alright well let me start with the Jefferson Rangers, Geram Properties, Denver Guards, and Joseph Blauw wells have not been permitted so there is no way to get an exemption.

Now on to the Tebo 29-2H the COGCC has fired back at us and said that there is a well within the ½ mile radius, this is permit number 111807. Prior to being given the approval we have to prove that there was an attempt to get a sample and provide the documentation. I looked at a map and there is only one well in that area so we do actually have to try on this one, I know you know that. Let me know if there is anything I can do to help out, I will try not to give you any more bad news.
