Environmental	On January 9, 2014, a Variance Request by MARATHON OIL COMPANY ("MOC") to the requirement set forth in Rule908.b.(5).D. requiring Centralized Exploration and Production Facilities (E&P) "to have a fire lane of at least ten (10) feet in width around the active treatment areas and within the perimeter fence. In addition, a buffer zone of at least ten (10) feet shall be maintained within the perimeter fire lane.", was granted to MARATHON OIL COMPANY OXY USA WTP LP (Operator no. 53650) for one (1) location (Facility no. 433736) in Garfield County. The existing impoundment is in terrain that precludes the construction of both the required 10 foot fire lane and 10 foot buffer zone.
