DB Orphan Blair, a.k.a. "the DeBeque Water-flow" on or about 7/7/2013 water from this well surfaced and was flowing at many (20?) gallons/minute. COGCC notified and after initial Environmental staff inspection and fluid-sampling, on 7/25 began work to temporarily stop flow. At first the source was thought to be a fluid/water pipeline about 2 or 3' below ground level -- after excavating about 3' the actual well was encountered. subcontractor (Magna Energy) suggested installing a pipe/riser into ~ 1" (i.d.) opening for the leaking pipe at top of wellhead. pipe/riser with valve installed to stop fluid-flow until permanent P&A (scheduled in 2014).
