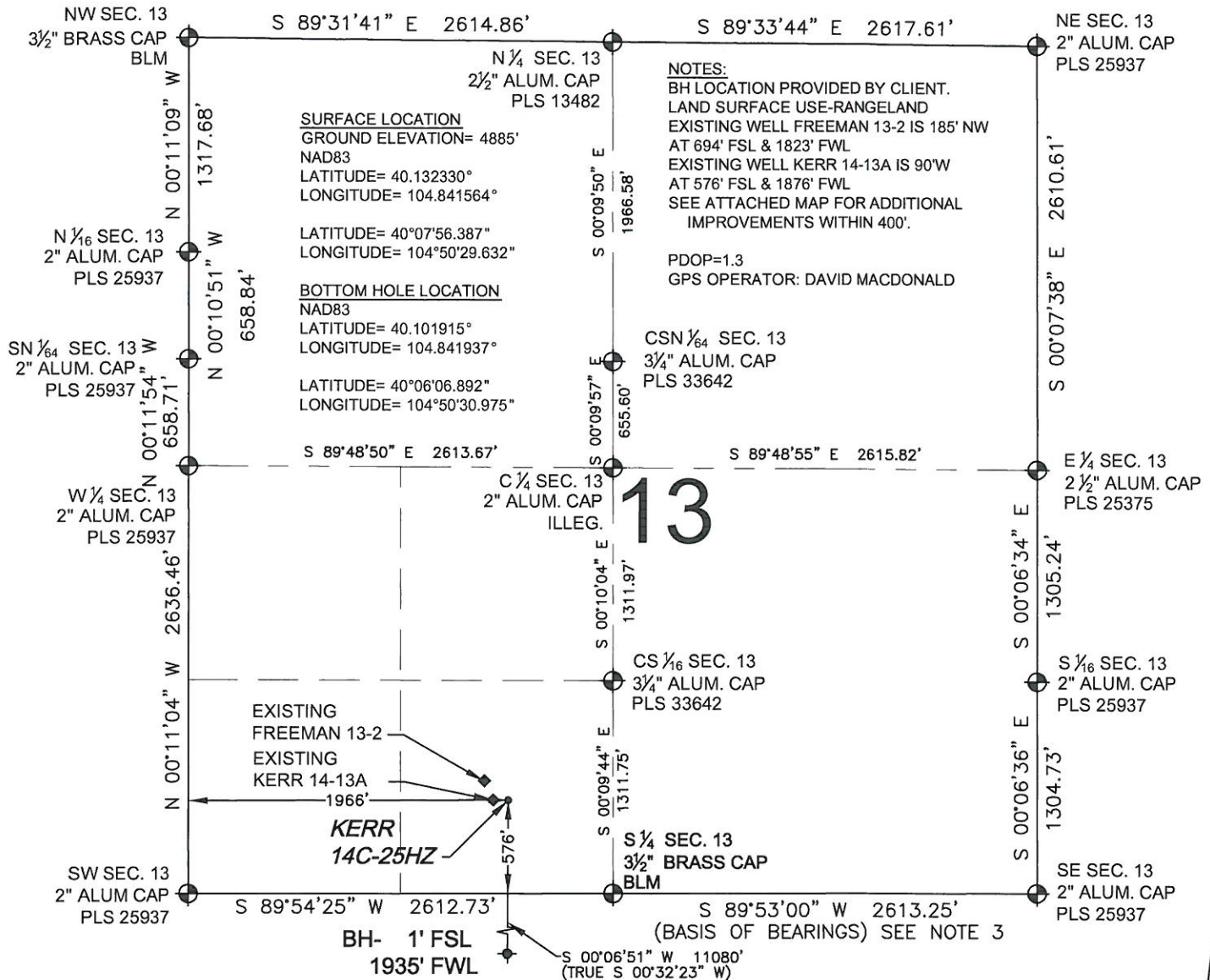
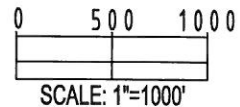

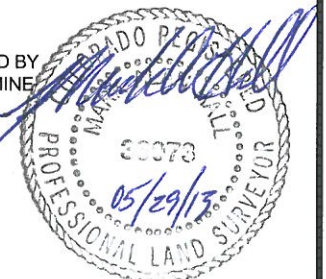


WELL KERR 14C-25HZ TO BE LOCATED 576' FSL AND 1966' FWL

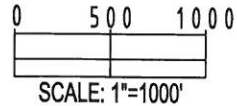

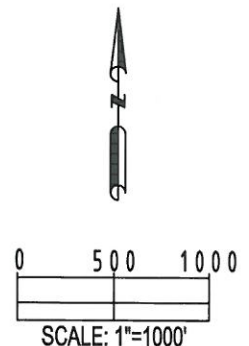
