Comments:

The Oxy Gunderson 12-2 pad, location #312643, has been fully reclaimed and is ready for inspection. The Gunderson Federal 12-2 well, API 077-08678, is located on this pad and was plugged and abandoned on 10/20/2011. A Form 4 Sundry Notice for interim reclamation was approved on 3/14/2013, document #2506414. Previously disturbed areas of location #312643 were re-contoured and slopes were reduced to minimize erosion and were reseeded. A uniform vegetative cover density of 80% of the pre-disturbance level has been achieved. Monitoring of the location for noxious weeds and stormwater BMPs has occurred. Areas that were not used for production facilities, access roads, or other production operations have been stabilized with vegetation. The location will continue to be monitored for noxious weed infestations.
