If Sussex coverage does not exist as required, provide this coverage as part of this plugging project.</p> <p>3) If unable to pull casing contact COGCC for plugging modifications.</p> <p>4) Change surface casing plug depth from 645' to 740' due to deeper aquifer in vicinity. Adjust cement volumes accordingly.</p> <p>5) For 740' plug: pump plug and displace. If surface casing plug not circulated to surface then tag plug – must be 545' or shallower and provide 10 sx plug at the surface. Leave at least 100' cement in the casing for each plug.</p> <p>6) Properly abandon flowlines as per Rule 1103.
