David,

Per our conversation on the phone earlier today about the Government 23-1, here is our procedure to repair the two holes in casing. After we finish the work we will send you a follow up sundry. When we first began work on the well there was 25 psi on the bradenhead, no pressure on the casing or tubing, and since work commenced our consultant has not noted any pressure. I have not been able to locate a CBL in your database or ours, but according to records on the COGCC website the production casing was cemented with 120 sacks of cement. After we repair the casing we will run a CBL.

 - 4a) Pump Cement Balanced Plug over this interval extending 200' above Hole
- 5) Larger Hole in Casing between 876'-891' with ability to circulate to surface
 - 5a) Set plug below hole, retainer above hole, and circulate cement to surface
- 6) Drill out cement in casing, and POOH
- 7) Run Cement Bond Log
- 8) Schedule MIT and submit subsequent report
