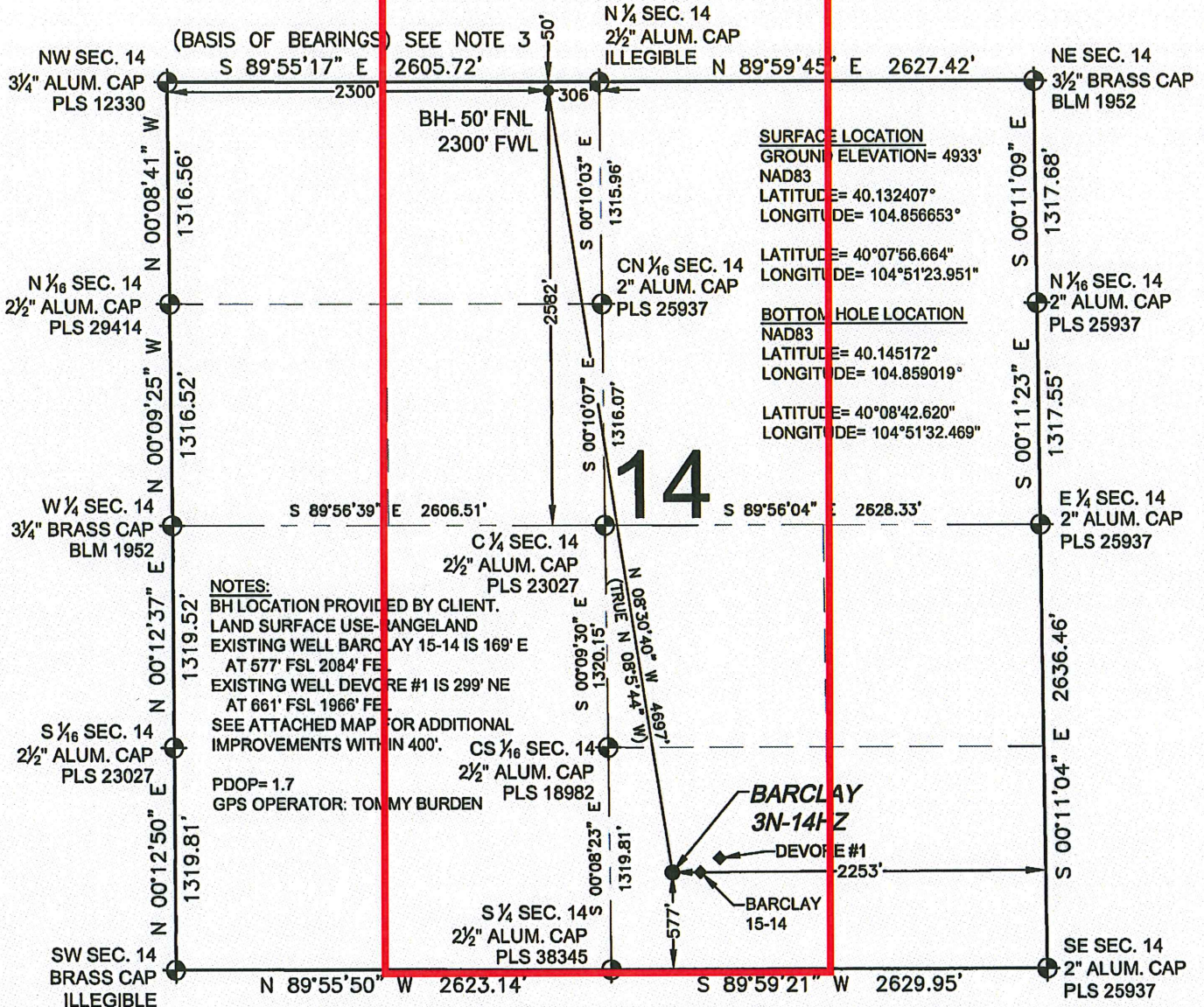

WELL BARCLAY 3N-14HZ TO BE LOCATED 577' FSL AND 2253' FEL

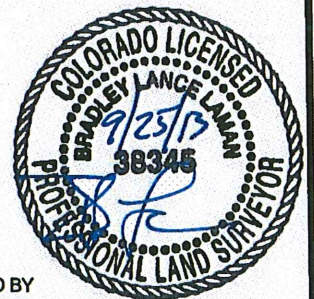

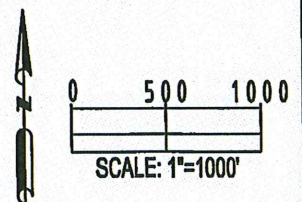
