Anadarko E&P Onshore, LLC. (Anadarko) respectfully requests authorization to flare on-lease gas from the Switchman 1647-17-11H with an above ground flare stack. This request is made due to the lack of natural gas gathering and processing infrastructure in the basin. The anticipated gas rate is expected to be less than 40 Mcf/d of which 8-10 Mcf/d will be used to operate on-lease equipment. All gas will be measured and reported on the monthly production report (Form 7).
