CHEVRON USA INC IS PLEASED TO SUBMIT THIS NOTIFICATION OF A PROPOSED CHANGE IN THE WELL EQUIPMENT ON THE INDIAN CREEK S.U. 13-2. A BURIED 2" CARBON STEEL DUAL FLOW LINE WILL BE INSTALLED FROM THE WELL-HEAD TO THE SEPARATOR CABINET ON THIS WELL TO ENHANCE PRODUCTION. A 95 BBL ABOVE-GROUND TANK (3'HIGH X 15' DIAM) WILL ALSO BE INSTALLED TO PROVIDE PROPER CONTAINMENT OF ANY LIQUIDS THAT POTENTIALLY MAY VENT FROM THE PRESSURE RELIEF VALVEE ON THE NEW DUAL FLOW LINE. ALL WORK WILL BE DONE ON THE WELL PAD ITSELF, THERE WILL NOT BE ANY NEW SURFACE DISTURBANCE OFF OF THE SITE.

A SCHEMATIC OF THE WELL PAD CHANGE IS ATTACHED, AS WELL AS THE BERM CONSTRUCTION GUIDELINES USED BY CHEVRON USA INC. A SCHEMATIC OF THE TANK DESIGN IS ALSO ATTACHED.
