

RELEASE

WHEREAS, Bonanza Creek Energy Operating Company, LLC (the "**Company**") hereby submits surface damage payment to Wetco Farms, Inc. (the "**Surface Owner**") covering crop loss located in the W/2 of Section 2, Township 4 North, Range 63 West, of Weld County, Colorado:

WHEREAS, the Company damaged 1.84 acres of crop to complete required operations to the Rothe 13-4, an Oil and Gas Well drilled by Rock Oil Corp in 1984, in order to properly adhere to the COGCC's Offset Well Requirements (the "**Operations**");

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the Company and the Surface Owner agree as follows:

1. The Company shall pay the Surface Owner per acre of lost crop. Bonanza Creek elects to pay Surface Owner for 2.0 acres of lost crop, which is the sum of n cash (the "**Payment**").

2. In exchange for the Payment, Surface Owner, on its own behalf and on behalf of its heirs, agents, representatives, attorneys, assigns, executors or anyone acting on its behalf, hereby fully releases the Company, the Company's past and present parents, subsidiaries and affiliates (collectively, "**Bonanza**") and Bonanza's officers, directors, managers, stockholders, members, partners, individual employees, agents, representatives, employees, attorneys, successors and anyone acting on their behalf (collectively with the Company and Bonanza, the "**Released Parties**"), from and waives all claims and causes of action by reason of any injuries and/or damages or losses, known or unknown, foreseen or unforeseen, patent or latent that the Surface Owner has sustained or which may be sustained as a result of any facts and circumstances arising out of or in any way related to the Operations, and to any other disputes, claims, disagreements or controversies between the Surface Owner and Bonanza up to and including the date this release is signed by the Surface Owner.

3. It is the Surface Owner's intent that this release is a general release which shall be effective as a bar to each and every claim, demand or cause of action it releases. The Surface Owner recognizes that the Surface Owner may have some claim, demand or cause of action against the Released Parties of which the Surface Owner is totally unaware and unsuspecting that the Surface Owner is giving up by execution of this release. It is the Surface Owner's intention in executing this release that it will deprive the Surface Owner of each such claim, demand or cause of action and prevent the Surface Owner from asserting it against the Released Parties.
