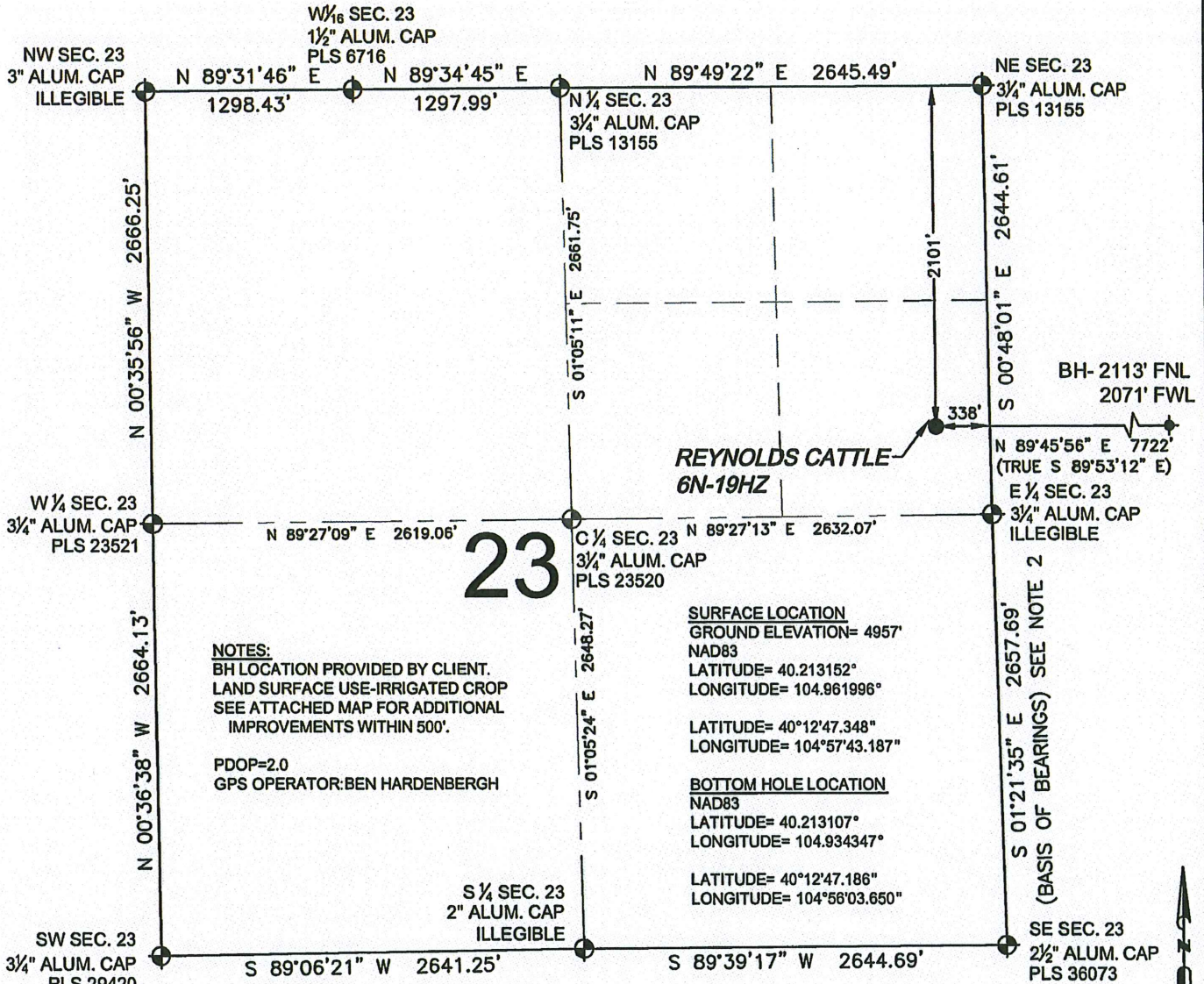

SECTION 23, TOWNSHIP 3 NORTH, RANGE 68 WEST, 6TH P.M.

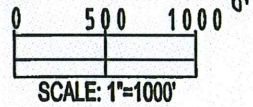
