OGLA	COGCC has removed the following statement from the 'Drilling & Waste Plans' tab under 'Drilling Waste Management Program': "FRESH WATER MUD WITH 3% DIESEL OIL AND OTHER ADDITIVES INCLUDING GILSONITE AND ASPHALT MAY BE UTILITZED." and changed 'Cuttings Disposal Method' to 'Cuttings Trench'. This correction was done based on an email dated 01-21-14 sent by Berry/Linn that stated: "In wells drilled before March 2011, 3% diesel was included in drilling fluids. Berry has not drilled any additional wells in our Piceance field since March 2011, and while we have no current plans to drill in the short/medium term, we have elected not to use diesel in drilling fluids in the future.
