## COMMENTS:

Oxy is providing this sundry notice to notify the COGCC of their intentions for remediation plans during 2014. Oxy's Piceance Basin asset is currently in the process of going through an asset sale. Oxy proposes to continue with current remediation activities (ISOCs and quarterly water sampling) until the transaction is complete allowing for the prospective buyer to provide input on final remediation activities. The prospective buyer could provide technology or insight into remediation activities in the future. Therefore, Oxy will postpone remediation activities until sale of the asset is complete. Oxy will continue quarterly water sampling of the location to support the monitoring program. Oxy will provide an update as to the sale status in 6-months and plans for remediation, if known.
