September 2013: Could not get a standard bridge plug through the wellhead. On 9/26/2013 we set an expandable bridge plug in the well at 2,718', dumped 3 sacks of sand on top of the plug, and chased the sand with water.

1/9/2014-1/10/2014. Killed well and nipped down B-section. Discovered the casing slips had not been set properly, and pinched the casing . The pinched casing was not allowing us to get standard size 5.5" casing tools down the well.

Our plan is to do an internal cut on the 5.5" production casing at 400' and then set an external casing patch to repair the pinched casing.
