Shallow surface water depression which is dry located 417' West of edge of well pad. Dirt berm will be placed on the West and North sides at edge of well pad to protect this area which will not be disturbed during drilling operations. Two tract dirt road (oil well road) located 422' South of well pad. This road will be used for access to drill site. No water wells within 5280' of well stake. Building located 3920' from well stake contains production equipment for the Aloha Mula Gas Plant.
