Comments:

Interim reclamation activities were conducted on the Durham Ranches 32-1 well pad location during spring 2013. Interim reclamation activities consisted of reworking the cut slope on the well pad location to minimize gradient. Activities also consisted of surface roughening techniques on the cut slope to enhance water capture and minimize erosion potential, in preparation of hydroseeding.

On May 8, 2013, hydroseeding and hydromulching with Flexterra was conducted on the cut slope on the Durham Ranches 32-1 well pad location. Approximately 0.75 acres was hydroseeded with seed mixture A from the stormwater management plan.

Additionally, noxious weed mitigation was also conducted in September 2013 at the Durham Ranches 32-1 location to inhibit future noxious weed growth and infestation. Ongoing monitoring will be conducted in 2014 to determine the effectiveness of the spring 2013 interim reclamation and autumn 2013 noxious weed mitigation measures.
