Comments:

Interim reclamation activities were conducted on the Gnat Hill 1-29 well pad location during autumn 2013. Interim reclamation activities consisted of reworking stormwater sediment catch basins and containment structures. Activities also consisted of some surface roughening techniques on cut and fill slopes to enhance moisture capture and minimize erosion potential, in preparation of hydroseeding.

On November 11, 2013, hydroseeding and hydromulching with Flexterra was conducted on the cut and fill slopes on the Gnat Hill 1-29 well pad location and in spot locations along the access road leading to the well pad. Hydroseeding application consisted of a seed mix approved by the Routt County Conservation District for non-crop lands, RCCD #2 seed mix. RCCD #2 was applied on approximately 2 acres at an application rate of 44.4 PLS lb/acre for a total seed application rate of 88.8 PLS lb.

Ongoing monitoring will be conducted in 2014 to determine the effectiveness of the autumn 2013 interim reclamation measures.
