Comments:

Interim reclamation activities were conducted on the Harper Hill 1-29/2-29 well pad location during autumn 2013. Interim reclamation activities consisted of compacting berms for slope stabilization and stormwater BMP practices. Activities also consisted of surface roughening techniques on cut and fill slopes to enhance moisture capture and minimize erosion potential, in preparation of hydroseeding.

On November 8, 2013, hydroseeding and hydromulching with Flexterra was conducted on the cut and fill slopes on the Harper Hill well pad location. Hydroseeding was also conducted in an area outside of the fenceline at the front entrance to the pad per surface owner request. Hydroseeding application used a seed mix approved by the Routt County Conservation District for non-crop lands, RCCD #1 seed mix. RCCD #1 was applied on approximately 1 acre at an application rate of 48.4 PLS lb/acre for a total seed application rate of 48.4 PLS lb.

Additionally, noxious weed mitigation was also conducted in September 2013 at the Harper Hill well pad location to inhibit future noxious weed growth and infestation. Ongoing monitoring will be conducted in 2014 to determine the effectiveness of the autumn 2013 interim reclamation and noxious weed mitigation measures.
