Flowback and stimulation fluids from the wells to be hydraulically stimulated from this frac pad should be sent to tanks, separators, or other containment/filtering equipment at the well pad site(s) before the fluids can be placed into any pipeline, storage vessel, or frac tanks at this location, or into tanker trucks for offsite disposal. The flowback and stimulation fluid tanks, separators, or other containment/filtering equipment at the well pad site(s) must be placed in an area with additional downgradient perimeter berming. The area where flowback fluids will be stored/reused at the frac pad site shall also have additional downgradient perimeter berming and must be constructed to be sufficiently impervious to contain any spilled or released material.
