MESA ENERGY PARTNERS IS PLANNING TO CONSTRUCT A NEW GATHERING LINE AND COMPRESSOR STATION, AND AS A RESULT HAS TO REROUTE THE FLOW LINE FOR THE APPROVED G11 WELL. THE ORIGINAL ROUTE OF THE APPROVED GATHERING LINE WENT SOUTH WEST FROM THE WELL TO A TIE IN POINT IN THE NWSW OF SECTION 11 ( SEE ATTACHED SURVEY PLAT). THE NEW LINE WILL HEAD NORTH EAST THROUGH SECTIONS 2 AND 1 TO A TIE-IN POINT ADJACENT TO MESA ENERGY PARTNERS' 1-9 WELL, LOCATED IN THE NESE OF SECTION 1, T2S, R99W. THE NEW G11 WELL PIPELINE ROUTE WAS THE ORIGINALLY-APPROVED ROUTE FOR THE 1-9 WELL PIPELINE ALTHOUGH NOW THE GAS WILL FLOW NE FROM THE G11 TO THE TIE IN POINT AT THE 1-9 INSTEAD OF FLOWING SW FROM THE 1-9 TO A TIE-IN POINT AT THE G11.
