OPERATOR COMMENTS AND SUBMITTAL

Comments: Offset well evaluation. Water Well Analysis:
Offset water well located in NE Quarter of Sec 31 is reported to be 341' deep. DWR records show that this well has 5" casing set at 243' and 4-3/4" hole to 341'. Offset oil and gas records combined with the DWR "Base Fox Hills" contour data indicate that the base of the Fox Hills reservoir in this area is +/-317'. So, even though the water well was drilled to a total depth of 341' it is still producing from the Fox Hills and all offset Oil and Gas wells in this review have adequately protected the Fox Hills either by setting surface casing below it or by covering it with cement during abandonment.

Location ID 309903 for the well location is an existing pad with the plan to expand and add wells. The location for the offsite production facilities will be an existing location that has no associated location ID, doc number is 400524779.

1	General Housekeeping	General housekeeping will consist of neat and orderly storage of materials and fluids. Wastes will be temporarily stored in sealed containers and regularly collected and disposed of at offsite, suitable facilities. If spills occur prompt cleanup is required to minimize any commingling of waste materials with storm water runoff. Routine maintenance will be limited to fueling and lubrication of equipment. Drip pans will be used during routine fueling and maintenance to contain spills or leaks. Any waste product from maintenance will be containerized and transported offsite for disposal or recycling. There will be no major equipment overhauls conducted onsite. Equipment will be transported offsite for major overhauls. Cleanup will consist of patrolling the roadways, access areas, and other work areas to pick up trash, scrap debris, other discarded materials, and any contaminated soil. 2	Drilling/Completion Operations	Prior to drilling operations, Operator will perform an anti-collision scan of existing offset wells that have the potential of being within close proximity of the proposed well. This anti-collision scan will include definitive MWD or gyro surveys of the offset wells with included error of uncertainty per survey instrument, and compared against the proposed well path with its respective error of uncertainty. If current surveys do not exist for the offset wells, Operator may have gyro surveys conducted to verify bottom hole location. The proposed well will only be drilled if the anti-collision scan results indicate that there is not a risk for collision, or harm to people or the environment. For the proposed well, upon conclusion of drilling operations, an as-constructed gyro survey will be submitted to COGCC with the Form 5.
