

**MEMORANDUM OF SURFACE USE AGREEMENT**

THIS MEMORANDUM OF SURFACE USE AGREEMENT, is made this 21 day of June, 2013, and provides notice of a Surface Use Agreement ("Agreement") dated June 21, 2013, by and between **Fred H. Poss and Joie A. Poss, husband and wife, individually and as joint tenants**, whose address is **39145 County Road 28, Hugo, CO 80821** ("Owner") and **CASCADE PETROLEUM LLC**, whose address is **1331 Seventeenth Street, Suite 400, Denver, CO 80202** ("Company").

Under the provisions of the Agreement, Owner has granted to Company a non-exclusive right of access on and across the Lands and a non-exclusive right to use the surface and subsurface to explore, develop, produce, transport, and market oil, gas, and associated hydrocarbons from the following described lands (the "Lands") located in Lincoln County, Colorado:

See Exhibit "A" attached hereto and by this reference made a part hereof

The Agreement grants Company the right to construct or install well pads, oil and gas flow lines, pipelines, gathering lines, telecommunication lines, electric lines, water lines, roads, compressors, processing facilities, tank batteries, and central facilities on the Lands, all of which may be utilized in connection with Company's operations on the Lands, as well as operations on other lands in which Company owns an oil and gas leasehold interest, subject to the terms of the Agreement.

The Agreement shall continue in full force and effect until Company's oil and gas leasehold estate covering the Lands (or other lands, to the extent the Lands are used in connection with Company's operations on such other lands pursuant to the terms of the Agreement) expires or terminates, Company ceases operations on the Lands (or other lands, to the extent the Lands are used in connection with Company's operations on such other lands pursuant to the terms of the Agreement) under the terms of the Agreement, or Company has plugged and abandoned any well(s) and conducted all required reclamation, whichever is later.

This Memorandum is executed by Owner and Company and recorded in Lincoln County, Colorado to serve as notice of the existence of the Agreement. The parties acknowledge they are bound by all the terms and conditions of the Agreement and that the Agreement binds and inures to the benefit of Owner and Company and their respective heirs, personal representatives, successors and assigns.

Owner shall provide a copy of this Agreement to any potential purchaser or transferee prior to the sale or transfer of all or any portion of the Lands.






